Driving for Mosaic during the Jewish Outdoor Escape

Due to insurance regulations, anyone driving as an "official" Mosaic activity driver is required to allow us to perform a check of their Motor Vehicle Record.

We will ask you to either:

- 1. Supply us a copy of your Motor Vehicle Report for the past three years. Most states/provinces have a way to do this online.
 - a. It is as simple as
 - i. Filling out the online form from your local Department of Motor Vehicles to obtain your Motor Vehicle Drivers Record.
 - ii. Downloading and filling out the reimbursement form from the Attendee Info page on our website.
 - iii. Then send via email to Event@MosaicOutdoor.org:
 - 1. Copy of the Motor Vehicle Driver's Record
 - 2. The receipt of the purchase
 - 3. Reimbursement form

- 2. Let us pull the record for you. You will need to sign a permission form with pertinent data. We will then pull your MVR record via https://www.mvronline.com/.

We will allow anyone to drive for Mosaic if you have a good driving record. You are allowed one or two minor traffic tickets, but no significant accidents where you are found at fault, or DUIs. Please do not put us in any embarrassing situations by volunteering to drive if you would not pass the MVR check.

Please consider pulling your own record

- 1. MVROnline vendor does charge considerably more than for this service than going directly to the source.
- 2. The time it takes for your volunteer Chairpeople to make it happen.
